

# Regulations Camping Julianahoeve

Camping Julianahoeve is affiliated with RECRON, which means that the general RECRON-conditions apply on our campground. These conditions can be obtained at the reception. Besides the RECRON conditions, we also apply the below stated regulations of Camping Julianahoeve;

#### **Article 1 : Arrival and departure**

Accommodations

At your day of arrival, the chalet is available from 3:30PM. Time of departure is before 10:30AM.

- Placement of (party)tents is prohibited.
- Baby cots can be reserved in advance without additional costs.
- It is not allowed to dig on the site.
- Our chalets and bungalow are non-smoking.
- It is not allowed to stay overnight with more than 6 persons in one chalet or bungalow.

#### Pitches

At your day of arrival, the camping pitch is available from 1PM. Time of departure is before 11AM.

- Maximal 1 additional tent of max. 4m2 is allowed.
- Do not dig on the site.
- A ground cloth may only be placed underneath the caravan awning. It is not allowed to place it underneath the additional canopy.
- The caravan has to be placed alongside the hedge.
- Electricity closets, sewage and water wells should be kept clear at all times.
- A maximum of 6 persons is allowed per pitch.

#### **Article 2: Payment method**

Two weeks after reservation, 50% of the accommodation costs must be paid. The remaining amount must be paid 4 weeks prior to your arrival. In case the second payment term is not met, we will rent the camping pitch to others.

# Article 3: Register

Reception

Upon arrival, the recreant needs to visit the reception first (during opening hours). Please let us know during check-in when there are any changes regarding the persons signed up.

# **Article 4: Family campground**

We do not offer residence to youth aged under 21 travelling without adults. Youth under 21 years may only stay overnight at the campground when at least one of the parents or legal guardians stays at the same chalet/bungalow. Youth above 21 travelling in a group will only be accepted after permission.

### **Article 5 : Day visitors**

Day visitors need to leave the campground before 11PM. Please be sure that your day visitors follow our rules. We consider you to be responsible for the behavior of your guests. Day visitors do not have access to the swimming pool during holiday periods and weekends.

#### Article 6 : Pets

Pets are not allowed on our campground.

#### **Article 7: Fire hazards**

It is not permitted to make open fires (e.g. a bonfire). The use of barbeques is allowed, provided that it is done in a safe way and that it does not disturb other guests.

#### Article 8: Car- or motor usage

- We request you to minimize the use of motorize vehicles on the campground and to drive at walking speed.
- It is possible to park one car near your accommodation or pitch. A second car or trailer can be parked at the parking lanes in front of the gate.

# Article 9 : Silence

- One has to take into account that it has to be silent at the campground and that it is not allowed to drive with motorized vehicles between 11PM and 7AM. During these times, the gate can only be opened in case of an emergency. Noise in the broadest sense of the term should be avoided at all times.
- 2. In case of repeated nuisance, the management reserves the right to deny access to the campground at all times.

#### **Article 10 : Waste management**

The campground offers opportunities to separate your waste. Garbage needs to be disposed in sealed bags. Please do not forget to close the garbage bins to prevent odor. Separate containers are available for green waste, plastic, paper, and glass.

#### Article 11 : Center area

The center of the campsite is only accessible for people by feet. Bicycles needs to be placed in front of this area. Go-karts, hover boards and steps are forbidden. Except for those who are needed in an electric chair.

#### **Article 12 : Drones**

It is forbidden to use drones on the campsite, because of privacy our guests.

# **Article 13 : Disordered behavior**

The management reserves the right to deny access to people who behave disorderly and who constantly ignore the prescribed rules.

### Article 14: Use of alcohol

Consumption of alcoholic beverages is only allowed in and around the accommodation and pitches, at the restaurant or café located at the center square of our campground. Parents or guardians are responsible for the consumption of alcohol among their children at all times.

# Atricle 15: In case of emergency

When the reception is closed, in case of emergency you can use the intercom on the gate to call the security or campsite owner.

Whenever there is an ambulance coming to the campsite, you need to inform the reception. When this is not during opening hours you can ring the intercom on the gate.

### **Article 16 : Cancellation insurance**

Of course we assume that you will spend your holiday at our campground. Though circumstances may occur which may lead to cancellation or early departure. Therefore we suggest you to arrange a travel insurance.
